MPORTANT TAX INFORMATION

Regarding Membership Dues paid to Tyler Area Builders Association, the portion attributable to "lobbying activities" is NOT deductible from federal income taxes as an ordinary and necessary cost of doing business per the 1993 U.S. Congress Omnibus Budget Reconciliation Act. For dues paid in 2011, the total amount of national dues that is NOT deductible as a business expense for a builder or associate member is \$27 and \$0.90 for an affiliate member; the total amount of state dues that is NOT deductible as a business expense for a builder or associate member is \$65.49 and \$14.75 for an affiliate member.

PRESIDENT'S MESSAGE



I'd like to explain some recent changes regarding new Builder member requirements. These changes went into effect in September of this year after months of study by a committee of long-time members and after their recommendations were approval by the TABA Board of Directors.

A little background might help explain why this is happening now. Starting many years ago TABA had certain requirements for builders who wanted to be members of this association. Then in 2004 the Texas Residential Construction Commission came into being with the mandate to register all builders and each home they built. During the TRCC years TABA made the decision to waive local requirements to avoid placing an extra burden on potential members. As long as a builder was registered with the TRCC, they were welcome to join the association.

When the TRCC went out of commission in late 2009, those mandates disappeared as well. Because of that our TABA-member committee began meeting earlier this year to establish membership requirements once again.
